SUMMER CAMP TERMS AND CONDITIONS

1. The School observes statutory holidays such as Canada Day on July 1, 2025. There will be no camp on this day.
2. A student will not be accepted into the School unless the entire enrolment form has been completed in full (with selected weeks ticked and signed). Application must be accompanied by Full payment, OHIP number or proof of health insurance. New students must provide a copy of their birth certificate, proof of citizenship status and immunization documentation.
3. Summer camp fees are due upon registration. Summer Camp fees are non-transferable to any other week or program, nor are they refundable. Once paid, there will be no refund of summer camp fees whatsoever, including but not limited to a student's withdrawal from the program for any reason. All summer camp classes and programs offered are subject to change and / or cancellation at any time, and are offered subject to sufficient enrolment, as determined by the School. Should the School decide to cancel a program due to low enrolment, all fees paid to date shall be fully refunded without interest or penalty.
4. There are no refunds for withdrawals, and no refunds for holidays, sick days, or days missed for any reason, throughout the summer camp.
5. The student's full name, program/grade, must be written on the front MEMO of each and every cheque/EMT and other modes of payment.
6. A charge of \$30.00 will be levied against all cheque payments returned for any reason.
7. Fees for summer camp are due upon registration. Students will not be allowed to attend unless payment has been made.
8. There is a late pick-up charge which is applied at the rate of \$1.00 per minute after 6:00 p.m. or at any time that SMS staff has to remain beyond established hours to care for a student due to a late pick up. Charges will be levied against parents who are late for 3.30pm and 6.00pm pick up.
9. The School reserves the right to accept or reject this application and also to expel a student at any time.
10. Withdrawal Procedure: The School requires written notice of a student's withdrawal; however, there will be no refund or transfer of the summer camp fees.
11. Due to an emergency, my child may only be released to the following person/(s) and the person signing this application. Alternate Pick-up personnel can be arranged. Please provide photo identification for this purpose.
12. All Parents and/or Guardians who are registering their child for Summer Camp, but are not currently enrolled in Sunrise are required by the Ministry to fill out the full Sunrise Registration / Enrolment Form.

Summer Camp Parent Agreement

In the event of any mishaps, an emergency, the school has my permission to administer first aid or any appropriate emergency treatment in the best interest of the child. I agree to pay all expenses incurred due to an emergency involving my child.
